Lemon laws vary in the states that have enacted them. Lemon laws may not exist in all states.
Salvage Auction	Title and ProblemCheck	An auction has reported the vehicle as a salvaged vehicle. The extent of damage is unknown, and the vehicle may or may not be severely damaged.
Salvage	Title and ProblemCheck	A salvage vehicle is a vehicle that has been wrecked or damaged beyond repair; declared a total loss by the insurer; or declared a total loss by reason of theft.
